

**Certification Requirements, Inspection Form, and Letterhead Certificate for the  
Export of Artemia (Brine Shrimp) Biomass or Cysts for Animal Feeding to  
Colombia**

The letterhead certificate for Artemia (brine shrimp), either biomass or cysts, below, is approved for the export of this material for animal feeding to Colombia.

The inspection format found below is used to inspect and approve those facilities that export Artemia cysts or biomass to Colombia. Facilities must be inspected annually in accordance with the certification statements on the approved letterhead certificate. The Area office conducting the inspection ensures that appropriate samples are collected, submitted for testing and found to be negative for the following disease agents: Taura syndrome, white spot disease, and yellow head disease. Facilities meeting these criteria are reported to NCIE Export Animals Products Staff and annually a list is sent to government of Colombia.

Please note that no APHIS reference number is included.
