|                               | <p>I, the undersigned official veterinarian, hereby certify:</p> <p>II.1. According to official information, the aquatic animals referred to in Box I.27 of Part I meet the following animal health requirements:</p> <p>II.1.1. The aquatic animals originate from <sup>(1)</sup>[an establishment] <sup>(1)</sup>[a habitat] which is not subject to national restriction measures for animal health reasons or because of the occurrence of abnormal mortalities with an undetermined cause, including the listed diseases referred to in Annex I to Commission Delegated Regulation (EU) 2020/692 <sup>A</sup> relevant for the species and emerging diseases.</p> <p>II.1.2. The aquatic animals are not intended to be killed under a national programme for the eradication of diseases, including the listed diseases referred to in Annex I to Delegated Regulation (EU) 2020/692 relevant for the species and emerging diseases.</p> <p><sup>(1)</sup>[II.2. The aquaculture animals of the consignment described in Box I.27 meet the following requirements:</p> <p>II.2.1. They come from an aquaculture establishment which is <sup>(1)</sup>[registered] <sup>(1)</sup>[approved] by, and under the control of, the competent authority of the third country or territory of origin and has a system in place to maintain and to keep for a period of at least three years, up-to-date records containing information regarding:</p> <p style="padding-left: 40px;">(i) the species, categories and number of aquaculture animals on the aquaculture establishment;</p> <p style="padding-left: 40px;">(ii) movements of aquatic animals into, and aquaculture animals out of, the aquaculture establishment;</p> <p style="padding-left: 40px;">(iii) mortality in the aquaculture establishment.</p> <p>II.2.2. They come from an aquaculture establishment which receives regular animal health visits from a veterinarian for the purpose of the detection of, and information on, signs indicative of the listed diseases referred to in Annex I to Delegated Regulation (EU) 2020/692 relevant for the species and of emerging diseases, at a frequency that is proportionate to the risk posed by the aquaculture establishment.]</p> <p><b>II.3. General health requirements</b></p> <p>The aquatic animals of the consignment described in Box I.27 meet the following animal health requirements:</p> <p>II.3.1. The aquatic animals originate from a <sup>(1)</sup>[country] <sup>(1)</sup>[territory], <sup>(1)</sup>[zone] <sup>(1)</sup>[compartment] with code: ____ - ____ <sup>(2)</sup> which, at the date of issuing this animal health certificate is listed in Part 1 of Annex XXI to Commission Implementing Regulation (EU) 2021/404 <sup>B</sup> for the entry into the Union of certain species of aquatic animals.</p> <p>II.3.2. They have undergone clinical inspection in accordance with Article 166 of Delegated Regulation (EU) 2020/692 within a period of 72 hours prior to the time of loading. During the inspection, the aquatic animals showed no clinical symptoms of transmissible disease and, according to the relevant records of the aquaculture establishment, there was no indication of disease problems.</p> <p>II.3.3. They will be dispatched to the Union directly from the establishment of origin.</p> <p>II.3.4. The aquatic animals referred to in Box I.27 of Part I are aquatic animals destined for a confined establishment fulfilling the requirements of Article 9 of Commission Delegated Regulation (EU) 2020/691 <sup>E</sup> where they are to be used for research purposes.]

<sup>(1)</sup>or [II.4. **Specific health requirements**

The aquatic animals referred to in Box I.27 are wild aquatic animals which, <sup>(1)</sup>[have been subject to quarantine in an establishment approved for that purpose by the competent authority in the <sup>(1)</sup>[country] <sup>(1)</sup>[territory] of origin in accordance with Article 15 of Delegated Regulation (EU) 2020/691.] <sup>(1)</sup>[will be subject to quarantine in an establishment which is approved for that purpose in accordance with Article 15 of Delegated Regulation (EU) 2020/691.]

II.5. To the best of my knowledge, and as declared by the operator, the animals in the consignment show no symptoms of disease and come from <sup>(1)</sup>[an establishment] <sup>(1)</sup>[a habitat] where:

- (i) there were no abnormal mortalities with an undetermined cause; and
- (ii) the aquatic animals have not been in contact with kept animals of <sup>(3)</sup>listed species which did not comply with the requirements referred to in point II.1.

**II.6. Transport requirements**

Arrangements have been made to transport the aquatic animals referred to in Box I.27 in accordance with the requirements laid down in Articles 167 and 168 of Delegated Regulation (EU) 2020/692 and specifically that:

II.6.1. the aquatic animals are dispatched to the Union directly from the establishment of origin and are not unloaded from their container when transported by air, sea, railway or by road;

II.6.2. the water in which they are transported is not changed in a third country or territory, zone or compartment which is not listed for entry into the Union of the particular species and category of aquatic animals;

II.6.3. the animals are not transported under conditions that jeopardise their health status, in particular:

- (i) when the aquatic animals are transported in water, it does not alter their health status;
- (ii) the means of transport and the containers are constructed in such a way that the health status of the aquatic animals is not jeopardised during transportation;
- (iii) the <sup>(1)</sup>[container] <sup>(1)</sup>[well-boat] is previously unused or cleaned and disinfected, in accordance with a protocol and with products approved by the competent authority of the <sup>(1)</sup>[third country] <sup>(1)</sup>[territory] of origin, prior to loading for dispatch to the Union;

II.6.4. from the time of loading at the establishment of origin until the time of arrival in the Union, the aquatic animals in the consignment described in Box I.27 are not transported in the same water or <sup>(1)</sup> [container] <sup>(1)</sup> [well-boat] together with aquatic animals which are of a lower health status or which are not intended for entry into the Union;

II.6.5. where a water exchange is necessary in a <sup>(1)</sup> [third country] <sup>(1)</sup> [territory] <sup>(1)</sup> [zone] <sup>(1)</sup> [compartment] which is listed for entry into the Union of the particular species and category of aquatic animals, it only occurs <sup>(1)</sup>[in the case of transport on land, at water exchange points approved by the competent authority of the <sup>(1)</sup> [third country] <sup>(1)</sup> [territory] where the water exchange takes place.] <sup>(1)</sup>[in the case of transport by well-boat, at a distance which is at least 10 km from any aquaculture establishments which are located en-route from the place of origin to the place of destination in the Union.]

**II.7. Labelling requirements**

Arrangements have been made to identify and label the <sup>(1)</sup> [means of transport] <sup>(1)</sup> [containers] in accordance with Articles 169(1) and 169(2) of Delegated Regulation (EU) 2020/692 and specifically that:

II.7.1. the consignment is identified by <sup>(1)</sup> [a legible and visible label on the exterior of the container] <sup>(1)</sup> [an entry in the ships manifest when transported by well-boat,] which clearly links the consignment to this animal health certificate;

II.7.2. the legible and visible label will contain at least the following information:

- (a) the number of containers in the consignment;
- (b) the name of the species present in each container;
- (c) the number of aquatic animals in each container for each of the species present;
- (d) the purpose for which the aquatic animals are intended.

**II.8. Validity of the animal health certificate**

This animal health certificate is valid for a period of 10 days from the date of issuing. In the case of transport by waterway/sea of aquatic animals, this period of 10 days may be extended by the duration of the journey by waterway/sea.

**Notes**

In accordance with the Agreement on the withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and the European Atomic Energy Community, and in particular Article 5(4) of the Protocol on Ireland / Northern Ireland in conjunction with Annex 2 to that Protocol, references to European Union in this certificate include the United Kingdom in respect of Northern Ireland.

‘Aquatic animals’ are animals as defined in Article 4, point (3), of Regulation (EU) 2016/429.

‘Aquaculture animals’ are aquatic animals which are subject to aquaculture as defined in Article 4, point (7) of Regulation (EU) 2016/429.

This animal health certificate is intended for entry into the Union of aquatic animals for the purposes indicated in in the title of the certificate, including when the Union is not the final destination of those animals.

This animal health certificate shall not be used for the entry into the Union of aquatic animals intended for human consumption in accordance with Regulation (EC) No 853/2004 of the European Parliament and of the Council <sup>H</sup> and Commission Regulation (EC) No 2073/2005 <sup>I</sup>, including those animals which are intended for the following aquaculture establishments:

- (i) a disease control aquatic food establishment as defined in Article 4, point (52), of Regulation (EU) 2016/429, or
- (ii) a dispatch centre as defined in Article 2, point (3), of Delegated Regulation (EU) 2020/691.

For those aquatic animals, the model certificate FISH-CRUST-HC, as set out in Chapter 28 of Annex III to Commission Implementing Regulation (EU) 2020/2235 <sup>F</sup>, or MOL-HC as set out in Chapter 31 of Annex III to that Regulation, must be used, as relevant.

This animal health certificate shall be completed according to notes for the completion of certificates provided for in Chapter 4 of Annex I to Implementing Regulation (EU) 2020/2235.
