



Funding Available to Help Tribes Protect Livestock Health: National Animal Disease Preparedness and Response Program

In 2025, the U.S. Department of Agriculture's Animal and Plant Health Inspection Service (APHIS) will provide up to \$17 million—with \$500,000 set aside just for Tribes—to help producers protect the health and value of their livestock, prevent the introduction and spread of foreign animal diseases, and combat livestock disease outbreaks. APHIS will seek project proposals in fall 2024. Projects selected for funding will be awarded in 2025.



Quick Facts for Tribes

- ▲ The National Animal Disease Preparedness and Response Program (NADPRP) strengthens Tribal Nations' ability to prevent the introduction and spread of foreign and emerging livestock diseases and combat animal disease outbreaks.
- ▲ Native American Tribes and governments, Tribal organizations, and Tribal colleges and universities can use the funding to carry out projects that help prepare for the most critical animal health threats facing livestock producers.
- ▲ Projects are vital for protecting animal health, public health, and Tribal food sovereignty and security.
- ▲ There are no cost-sharing requirements.
- ▲ Eligible Tribal programs can submit multiple project proposals.

About NADPRP

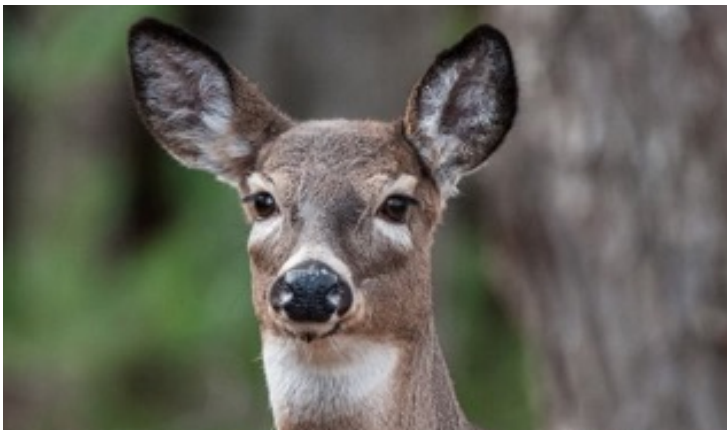
The 2018 Farm Bill established NADPRP as part of an overall strategy to help prevent animal pests and diseases from entering the United States and reduce the spread and impact of potential disease incursions through advance planning and preparedness. The program enhances APHIS' efforts to protect animal health through collaborations with partners nationwide.

APHIS funds projects that are focused on advancing animal disease preparedness and response capabilities in the following priority areas:

- ▲ Developing, enhancing, and exercising animal disease outbreak emergency response plans
- ▲ Supporting livestock and poultry biosecurity measures and programs



- ▲ Enhancing the capability and capacity for depopulation, carcass disposal, and decontamination in a disease outbreak
- ▲ Supporting animal movement decisions in a disease outbreak
- ▲ Enhancing animal disease traceability during a disease outbreak
- ▲ Developing and delivering training and exercises to improve animal disease outbreak response capabilities
- ▲ Supporting outreach and education on animal disease prevention, preparedness, and response
- ▲ Enhancing aquatic animal disease preparedness and response
- ▲ Enhancing equine disease outbreak prevention and response
