## Part II. Certification

I, the undersigned official veterinarian, declare that I have read and understood Regulation (EC) No 1069/2009, and in particular Article 10 of that Regulation, and Commission Regulation (EU) No 142/2011, and in particular Chapter II of Annex XIII and Chapter II of Annex XIV thereto, and certify that the dogchews described above:

II.1 have been prepared exclusively with the following animal by-products:

- (i) carcasses or bodies and parts of animals which are rejected as unfit for human consumption in accordance with retained EU law, but which did not show any signs of disease communicable to humans or animals;
  - (ii) heads of poultry;
  - (iii) hides and skins, including trimmings and splitting thereof, horns and feet, including the phalanges and the carpus and metacarpus bones, tarsus and metatarsus bones;
  - (iv) pig bristles;
  - (v) feathers;]
- <sup>(4)</sup>~~and/or [- blood of animals which did not show any signs of disease communicable through blood to humans or animals, obtained from animals that have been slaughtered in a slaughterhouse after having been considered fit for slaughter for human consumption following an ante-mortem inspection in accordance with retained EU law;]~~
- <sup>(4)</sup>~~and/or [- animal by-products arising from the production of products intended for human consumption, including degreased bone, greaves and centrifuge or separator sludge from milk processing;]~~
- <sup>(4)</sup>~~and/or [- aquatic animals, and parts of such animals, except sea mammals, which did not show any signs of disease communicable to humans or animals;]~~
- <sup>(4)</sup>~~and/or [- animal by-products from aquatic animals originating from plants or establishments manufacturing products for human consumption;]~~
- <sup>(1)</sup>and/or [- material from animals which have been treated with certain substances which are prohibited by Council Directive 96/22/EC, the import of the material being permitted in accordance with Article 35(a)(ii) of Regulation (EC) No 1069/2009;]

<sup>(1)</sup>~~either~~ [in the case of dogchews made from hides and skins of ungulates or from fish, to a treatment sufficient to destroy pathogenic organisms (including *salmonella*); and the dogchews are dry;]

<sup>(1)</sup>~~and/or~~ [in the case of dogchews made from animal by-products other than hides and skins of ungulates or from fish, to a heat treatment of at least 90°C throughout their substance;]

II.3 were examined by random sampling of at least five samples from each processed batch taken during or after storage at the processing plant and complies with the following standards <sup>(2)</sup>:

*Salmonella*: absence in 25g: n = 5, c = 0, m = 0, M = 0

*Enterobacteriaceae*: n = 5, c = 2, m = 10, M = 300 in 1 gramme;

(c) animal by product or derived product obtained from bovine, ovine or caprine animals which have been killed, after stunning, by laceration of the central nervous tissue by of an elongated rod-shaped instrument introduced into the cranial cavity, or by means of gas injected into the cranial cavity, except for those animals that were born, continuously reared and slaughtered in a country or region classified as posing a negligible BSE risk as set out in a document relating to 'BSE risk status' published on gov.uk, in accordance with Regulation (EC) No 999/2001.]]]

## Notes

References to European Union legislation within this certificate are references to direct EU legislation which has been retained in Great Britain (retained EU law as defined in the European Union (Withdrawal) Act 2018) and can be viewed on the UK legislation website ([legislation.gov.uk](http://legislation.gov.uk)).

References to Great Britain in this certificate include Channel Islands and Isle of Man.

- Box reference I.6: Person responsible for the consignment in Great Britain: this box is to be filled in only if it is a certificate for transit commodity: it may be filled in if the certificate is for a commodity to be imported into Great Britain.
- Box reference I.12: Place of destination: this box is to be filled in only if it is a certificate for a transit commodity. Products in transit may only be stored in free zones, free warehouses and custom warehouses.
- Box reference I.15: Registration number (railway wagons or container and lorries), flight number (aircraft) or name (ship); the information is to be provided in the event of unloading and reloading in Great Britain.
