I, the undersigned official veterinarian, declare that I am aware of the relevant requirements of the GB Regulations, and certify that the hides and skins described in Part I of this certificate:

(b) <sup>(\*)</sup>[has been free for at least 12 months before dispatch from foot-and-mouth disease and where, for 12 months before dispatch, no vaccination has been carried out against foot-and-mouth disease;]

#### AH/A751 Animal requirements

<sup>(\*)</sup>**OR** [were slaughtered in a slaughterhouse, after undergoing ante-mortem inspection, and were considered fit, for slaughter for human consumption in accordance with GB law;]

#### AH/P015 Product requirements (segregation)
