## Part II. Certification

I, the undersigned official veterinarian, declare that I have read and understood Regulation (EC) No 1069/2009, and in particular Article 8 and 10 thereof, and Commission Regulation (EU) No 142/2011, and in particular Chapter III of Annex XIII and Chapter II of Annex XIV thereto, and certify that the flavouring innards products described above:

II.1 consist of animal by-products that satisfy the animal health requirements below;

<sup>(†)</sup>~~and/or~~ [~~animal by-products arising from the production of products intended for human consumption, including degreased bone, greaves and centrifuge or separator sludge from milk processing;]~~

<sup>(†)</sup>~~and/or~~ [~~products of animal origin, or foodstuffs containing products of animal origin, which are no longer intended for human consumption for commercial reasons or due to problems of manufacturing or packaging defects or other defects from which no risk to public or animal health arise;]~~

<sup>(†)</sup>~~and/or~~ [~~petfood and feedingstuffs of animal origin, or feedingstuffs containing animal byproducts or derived products, which are no longer intended for feeding for commercial reasons or due to problems of manufacturing or packaging defects or other defects from which no risk to public or animal health arise;]~~

- <sup>(1)</sup>*and/or* [- blood, placenta, wool, feathers, hair, horns, hoof cuts and raw milk originating from live animals that did not show signs of any disease communicable through that product to humans or animals;]
- ~~<sup>(4)</sup>*and/or* [- aquatic animals, and parts of such animals, except sea mammals, which did not show any signs of diseases communicable to humans or animals;]~~

**II.3** have been subjected to processing in accordance with Chapter III of Annex XIII to Regulation (EU) No 142/2011, in order to kill pathogenic agents;

**II.4** was analysed by a random sampling of at least five samples from each processed batch taken during or after storage at the processing plant and complies with the following standards <sup>(2)</sup>:

*Salmonella*: absence in 25g: n = 5, c = 0, m = 0, M = 0,

*Enterobacteriaceae*: n = 5, c = 2, m = 10, M = 300 in 1 gram;

<sup>(1)</sup><sup>(3)</sup>or [(a) specified risk material as defined in point 1 of Annex V to Regulation (EC) No 999/2001 of the European Parliament and of the Council;

(b) mechanically separated meat obtained from bones of bovine, ovine or caprine animals, except from those animals that were born, continuously reared and slaughtered in a country or region classified as posing a negligible BSE risk as set out in a document relating to 'BSE risk status' published on gov.uk, in accordance with Regulation (EC) No 999/2001, in which there has been no indigenous BSE case,

(c) animal by-product or derived product obtained from bovine, ovine or caprine animals which have been killed, after stunning, by laceration of the central nervous tissue by means of an elongated rod-shaped instrument introduced into the cranial cavity, or by means of gas injected into the cranial cavity, except for those animals that were born, continuously reared and slaughtered in a country or region classified as posing a negligible BSE risk as set out in a document relating to 'BSE risk status' published on gov.uk, in accordance with Regulation (EC) No 999/2001.]

## Notes

References to European Union legislation within this certificate are references to direct EU legislation which has been retained in Great Britain (retained EU law as defined in the European Union (Withdrawal) Act 2018) and can be viewed on the UK legislation website ([legislation.gov.uk](http://legislation.gov.uk)).

References to Great Britain in this certificate include Channel Islands and Isle of Man.

**Part I:**

- Box reference I.6: Person responsible for the consignment in Great Britain: this box is required to be filled in only if it is a certificate for a commodity to be transited through Great Britain; it may be filled in if the certificate is for a commodity to be imported into Great Britain.
