    - (ii) heads of poultry;
    - (iii) hides and skins, including trimmings and splitting thereof, horns and feet, including the phalanges and the carpus and metacarpus bones, tarsus and metatarsus bones;
    - (iv) pig bristles;
    - (v) feathers;]
  - (1) and/or [- animal by-products arising from the production of products intended for humanconsumption, including degreased bone, greaves and centrifuge or separator sludgefrom milk processing;]
  - (1) and/or [- products of animal origin, or foodstuffs containing products of animal origin, which are no longer intended for human consumption for commercial reasons or due to problems of manufacturing or packaging defects or other defects from which no risk to public or animal health arises;]
  - (1) and/or [- petfood and feedingstuffs of animal origin, or feedingstuffs containing animal byproducts or derived products, which are no longer intended for feeding for commercialreasons or due to problems of manufacturing or packaging defects or other defectsfrom which no risk to public or animal health arises;]

- **II.5** the gelatine/collagen <sup>(1)</sup>:
  - (a) was wrapped, packaged, stored and transported under satisfactory hygiene conditions, and wrapping and packaging took place in a dedicated room, and only preservatives permitted under retained EU law were used.
