- ~~(i) classical scrapie is compulsorily notifiable;~~
  - ~~(ii) an awareness, surveillance and monitoring system is in place for classical scrapie;~~
  - ~~(iii) official restrictions apply to holdings of ovine or caprine animals in the case of a suspicion of TSE or the confirmation of classical scrapie;~~
  - ~~(iv) ovine and caprine animals affected with classical scrapie are killed and destroyed;~~
  - ~~(v) the feeding to ovine and caprine animals of meat and bone meal or greaves, as defined in the Terrestrial Animal Health Code of the World Organisation for Animal Health (WOAH (formerly OIE)), of ruminant origin has been banned and effectively enforced in the whole country for a period of at least the preceding seven years.~~
- ~~(b) originate from holdings where no official restrictions are imposed due to a suspicion of TSE.~~
- ~~(c) originate from holdings where no case of classical scrapie has been diagnosed during the period of the~~

preceding seven years or, following the confirmation of a case of classical scrapie:

- EITHER** all ovine and caprine animals on the holding have been killed and destroyed or slaughtered, except for breeding rams of the ARR/ARR genotype, breeding ewes carrying at least one ARR allele and no VRQ allele and other ovine animals carrying at least one ARR allele;
- OR** all animals in which classical scrapie was confirmed have been killed and destroyed, and the holding has been subjected for a period of at least two years since the date of confirmation of the last classical scrapie case to intensified TSE monitoring, including testing with negative results for the presence of TSE in accordance with the laboratory methods set out in point 3.2 of Chapter C of Annex X to Regulation (EC) No 999/2001, of all of the following animals which are over the age of 18 months, except ovine animals of the ARR/ARR genotype:
- animals which have been slaughtered for human consumption; and
  - animals which have died or been killed on the holding but which were not killed in the framework of a disease eradication campaign.

### PH/D011B Bovine spongiform encephalopathy (BSE)

In the case of gelatine or collagen described in Part I of this certificate, derived from ruminant materials other than hides and skins:

- EITHER** is derived from other ruminants than bovine, ovine or caprine animals.
- OR** is derived from bovine, ovine or caprine animals, it does not contain and is not derived from:
- EITHER** (a) bovine, ovine and caprine materials other than those derived from animals born, continuously reared and slaughtered in a country or region classified as posing a negligible BSE risk as set out in a document relating to 'BSE risk status' published on GOV.UK, in accordance with Regulation (EC) No 999/2001<sup>(†)</sup>;
- OR** (b) the following:
- (i) specified risk material as defined in point 1 of Annex V to Regulation (EC) No 999/2001 of the European Parliament and of the Council and mechanically separated meat obtained from bones of bovine, ovine or caprine animals, except from those animals that were born, continuously reared and slaughtered in a country or region classified as posing a negligible BSE risk as set out in a document relating to 'BSE risk status' published on GOV.UK, in accordance with Regulation (EC) No 999/2001<sup>(†)</sup>, in which there have been no indigenous BSE cases.
- (ii) animal by product or derived product obtained from bovine, ovine or caprine animals which have been killed, after stunning, by laceration of the central nervous tissue by means of an elongated rod-shaped instrument introduced into the cranial cavity, or by means of gas injected into the cranial cavity, except for those animals that were born, continuously reared and slaughtered in a country or region classified as posing a negligible BSE risk as set out in a document relating to 'BSE risk status' published on GOV.UK, in accordance with Regulation (EC) No 999/2001<sup>(†)</sup>.
