- I, the undersigned USDA accredited veterinarian, certify the following statements:
- 1. The United States is free of foot and mouth disease (FMD), rinderpest, and Rift Valley fever (RVF).
- 2. The animals for export have remained continuously in the premises of origin since birth, or for at least six (6) months, prior to shipment.
- 3. The premises of origin (i.e., zoo, farm, captivity) must be officially registered with the competent veterinary authority in accordance with U.S. regulations, and subject to regular inspection by the USDA accredited veterinarian.
- 4. The animals for export have been free for at least twelve (12) months prior to shipment, of clinical cases from the following diseases: Epizootic Hemorrhagic Disease, Malignant Catarhal Fever, Paratuberculosis (Johne's Disease), Mucosal Disease, Parainfluenza, Black Leg, Pseudotuberculosis, Brucellosis, Erysipelas, Rocky Mountain Spotted Fever, Q Fever, Anaplasmosis, Anthrax, Ruminant Babesiosis, Bluetongue, Lumpy Skin Disease, Rabies, Eperythrozoonosis, Vibriosis, Clostridial Infection, Contagious Pustula Dermatitis, Actinobacillosis, Actinomycosis, Malignant Edema, Encephalomyelitis, Streptococcosis, Listeriosis, Dermatomycosis, Pasteurellosis and Salmonellosis.
- 5. The animals for export were isolated for at least 30 days prior export in a facility approved by the USDA accredited veterinarian.
- 6. The animals for export were kept on a premises where no cases of tuberculosis and anthrax were officially reported for six (6) months prior shipment.
- 7. The animals for export were dipped or sprayed with a systemic insecticide at least twice prior to export; the first treatment is carried out 14 days prior and the second treatment within two (2) days prior to shipment.
