

## **NON-ANIMAL ORIGIN ANIMAL FEED PRODUCTS** **EXPORTED TO JAPAN**

The following certificate may only be endorsed for feed products intended for feeding to animals. No additional certificate or certifications may be endorsed by Veterinary Services for these materials exported to Japan.

The government of Japan has not yet confirmed the acceptability of this certificate for all products. As always, the exporter should have their importer confirm with the appropriate officials within the Japanese government prior to shipment that the certificate meets all necessary requirements. If the exporter requires additional certifications, we recommend that the exporter contact FDA for assistance.

The referenced affidavit must be provided by the **manufacturer** of the exported product, and signed by an official working for the manufacturer that has first hand knowledge of the accuracy of the statement. The affidavit must be presented to the endorsing Veterinary Services office with the certificate, but does not become part of the certificate nor need to be provided to Japan.

**This certificate may not be provided for materials that contain vitamin D3 originating from wool grease or materials containing vitamins with animal-origin gelatin coatings. Japan has other certification requirements for materials containing these ingredients. These requirements are currently under negotiation for livestock species (not including horses).**
