

- 4. Brucellosis: The animals originate from a state in which no case of brucellosis has been reported during the year prior to shipment.
- 5. Caprine arthritis/encephalitis (for goats):
- [O] Disease was neither clinically nor serologically diagnosed in the flocks of origin during the past three years, and no goat from a flock of inferior health status was introduced into these flocks during that period.
- [O] Intact male goats were tested for caprine arthritis/encephalitis with negative results within 30 days prior to shipment.

6. Maedi-visna:

- [O] Disease was neither clinically nor serologically diagnosed in the flocks of origin during the past three years, and no sheep or goat from a flock of inferior health status was introduced into these flocks during that period.
- [0] Intact males were tested for maedi-visna with negative results within 30 days prior to shipment.
- 7. Mycobacterium tuberculosis complex (for goats): The goats originate from states in which no case of infection with M. tuberculosis complex has been reported for the past three years.

- 8. New world screwworm:
 - [O] The United States is free from new world screwworm.
- [O] The animals did not reside in or transit through a control area for screwworm in the United States during the 21 days prior to shipment; and the animals were inspected by a USDA Accredited Veterinarian and were found free of fresh wounds or wounds in the process of healing and free of clinical signs of screwworm.
- 9. Q fever: The animals will be examined by an APHIS veterinarian within 48 hours prior to export and do not show any clinical signs of Q fever.
- 10. Rabies: The animals originate from an establishment where there has been no case of rabies for at least 12 months prior to shipment.
- 11. Scrapie: The animals originate from the United States where scrapie disease is compulsorily notifiable; an awareness, surveillance and monitoring system for scrapie disease is in place; and sheep and goats affected with scrapie are killed and completely destroyed. The sheep and goats showed no clinical signs of scrapie on the day of inspection.
- 12. The animals do not come from an area under veterinary restriction due to an outbreak of an infectious disease in sheep/goats; and must not be animals which have been culled under a national program to control and eradicate a contagious or infectious disease.
- 13. The animals selected for export were born after the date from which the ban on the feeding of ruminants with meat-and-bone meal and greaves derived from ruminants was effectively enforced.
- 14. The animals originate from a flock in which no other WOAH-listed diseases affecting sheep/goats have been reported during the past 1 month prior to shipment.
- 15. The animals will be transported in vehicles that were cleaned and disinfected using products approved for use in the United States.
