

Important Information Regarding Known Trade Bans on Various Products

I. Avian Influenza Bans

Prohibition on the export to or transit of Kazakhstan of raw poultry-derived pet food ingredients intended for the manufacture of pet food, untreated game trophies of feathered game, down and feathers of poultry, and technical gelatin derived from poultry originating from the State of:

- Alaska on or after October 5, 2022, but prior to November 1, 2023;
- Alabama on or after October 27, 2023;
- Arizona on or after November 13, 2024
- Arkansas on or after October 31, 2023;
- California on or after November 20, 2023;
- Colorado on or after December 14, 2023;
- Delaware on or after February 22, 2022 but prior to April 3, 2023;
- Delaware on or after January 4, 2025

- Mississippi on or after November 4, 2022, but prior to November 1, 2023; on or after December 20, 2024
- Missouri on or after November 6, 2023;
- Montana on or after October 08, 2023;
- Nebraska on or after February 6, 2024;
- Nevada on or after October 17, 2022;
- New Hampshire on or after September 23, 2022 , but prior to June 1, 2023;
- New Jersey on or after November 24, 2023;
- New Mexico on or after April 12, 2024
- New York on or after March 23, 2022 but prior to April 26, 2023; on or after March 15, 2024
- North Carolina on or after February 9, 2024;
- North Dakota on or after November 15, 2023;
- Ohio on or after November 21, 2023;
- Oklahoma on or after April 30, 2022 but prior to August 11, 2022;
- Oklahoma on or after December 3, 2024;
- Oregon on or after October 20, 2023;
- Pennsylvania on or after April 15, 2022;
- Puerto Rico on or after January 13, 2025;
- South Carolina on or after December 31, 2024;
- South Dakota on or after March 5, 2022;
- Tennessee on or after September 15, 2022, but prior to November 1, 2023;
- Tennessee on or after November 29, 2024
- Texas on or after April 11, 2024;
- Utah on or after October 14, 2023;
- Virginia on or after January 19, 2023 but prior to July 28, 2023;

- Virginia on or after January 21, 2025
- Washington on or after October 27, 2023;
- West Virginia on or after January 3, 2025
- Wisconsin on or after November 22, 2023.
