# Mexico - Important information regarding trade bans and other restrictions

# Highly Pathogenic Avian Influenza (HPAI) restrictions on poultry products:

The following products containing poultry ingredients are ineligible for export to Mexico *if* they have not been treated as indicated in the export certificate. No product from a restricted region can be exported, regardless of date until the region has been released.

- Animal feeds and food: Additives, Complements and Supplements for Animal Feeding (098-14-1246- USA-USA)
- Animal feeds and food: Balanced animal feeds (not including dogs and cats) (098-14-85-USA-USA)
- Animal feeds and food: Balanced pet foods for dogs and cats (098-14-1118-USA-USA)
- Animal Feeds and Foods: Processed pet treats (dogs and cats) containing animal origin ingredients (098-14-70-USA-USA)
- Animal Feeds and Foods: Balanced feeds containing porcine and poultry ingredients and intended for aquatic species (99-121-8048-USA-USA)
- Animal feeds and food: Raw material for Manufacturing Food for Feeding Aquatic Animals (99-121-8038-USA-USA)

Note: The phrase "originating from" refers to birds shipped from the restricted State during the restricted period for immediate slaughter. It does not refer to birds raised during the restricted period in the restricted States as long as they are slaughtered after the end of the restriction.
