Deputies from the Navajo County Sheriff's Off ce did observe various animals as reported by Mr. Caldwell, who had been shot and were deceased. Other animals were not deceased but had sustained gunshot wounds, some mortally wounded and suffering, others only wounded and who returned inside of Mr. Caldwell's fenced property. Many of the deceased or wounded animals were left to die or already dead, in a waterway known as the L ttle Colorado River canyon. Investigators with the Navajo County Sheriff's Office need to have verification that this was or was not an operation conducted by the US Department of Agriculture. Furthermore, investigators need to determine if this was a sanctioned operat on of the US Department of Agriculture (as described in the National Feral Swine Damage Management 5 Year Report found on the USDA Animal and Plant Health Inspect on Service website). As this aircraft entered Navajo County at very low altitudes and a firearm was fired from this aircraft without any advanced notice to local or state law enforcement, t is believed that such actions may have endangered the lives of persons on the ground, the shooting of the feral swine may be considered as cruelty to animals according to Arizona Revised Statutes 13 - 2910, and may have violated other local laws. As a result, please see the included Grand Jury subpoena for records from the Un ted States Department of Agriculture in relation to this on-going investigation. These records are anticipated to be of assistance the Navajo County Sheriff's Office in determining what further course of action, if any, need be taken by law enforcement regarding Mr. Caldwell's allegations as a private citizen who has suffered the loss of property and potentially been the victim of inappropriate con
