Dairy Products for Human Consumption Export to New Zealand

EXPORT CERTIFICATE

Information on the certificate, including the Manufacturer's Declaration, should be typed, not handwritten.

Both pages of the export certificate should be officially sealed by the endorsing VS Service Center.

MANUFACTURER'S DECLARATION

The Manufacturer's Declaration must be completed by someone with knowledge of the product, including its ingredients and how it was processed.

In Section I.1 of the Manufacturer's Declaration, a line should be drawn through the non-applicable portions.

In Section 2 of the Manufacturer's Declaration, the exporter must provide documentation from a competent public health agency verifying that the manufacturing facility is regulated/licensed/ and/or inspected as so stated. This supporting documentation must be provided on an annual basis.

ONWARD CERTIFICATION

Exporters with knowledge of intentional onward shipment of dairy products for human consumption from New Zealand to another country should be aware of any additional requirements or attestations required by the final destination country and alert the endorsing <u>Veterinary Services (VS) Service Center</u> at the time of certificate endorsement.

If an exporter has knowledge that the product will be forwarded **onward to Australia**, the following steps are recommended:

- Consult the relevant IREG for dairy exported directly to <u>Australia</u> to determine if any requirements have changed.
- ➤ Include any applicable disease freedom statements on the export certificate under section IV.

 Zoosanitary Information Veterinary Certification noted separately from the required statements for export to New Zealand. Purple text below is recommended for insertion following the currently existing attestations in blue.

For further export to Australia:
4. Country/Countries of origin of dairy ingredients;

- ➤ Indicate on the Manufacturer's Declaration when utilizing option 1.1.1 that the product was heated to a minimum temperature of 135°C for at least one (1) second, if appropriate, to minimize delays in the onward certification process.
- It is the exporter's responsibility to ensure that either the packaging or immediate container(s) indicate(s) the date of product manufacturing OR that the manufacturer's declaration provides the date of manufacture for each batch or lot number.
