## Important Information Regarding Known Trade Bans on Various Products Related to Animal Health

## I. Avian Influenza Bans

Effective July 24, 2024, Russia has suspended the movement of poultry products originating from the U.S. and transiting the Russian Federation.

Prohibition on the export to or transit of the Russian Federation of down and feathers of poultry, technical gelatin derived from poultry, or avian game trophies originating from the State of:

## III. Foot and Mouth Disease (FMD) Bans

Prohibition on the transit of animal product commodities through Hungary.
