

Live birds and hatching eggs originating and transiting States with detections of HPAI in POULTRY as defined by the World Organization for Animal Health (WOAH), are restricted from export to South Korea.

Note: The following statement on the health certificate for certification #2 must be selected at this time: *The U.S. is not free of HPAI; however, the day-old chicks for export were produced and hatched in HPAI free states and will only pass through HPAI-free states enroute to Korea. Additionally, the breeding farm/hatchery producing the day-old chicks participate in the National Poultry Improvement Plan (NPIP) and the breeding flock producing the day-old chicks shall be tested for HPAI in accordance with the NPIP, and the results shall be negative.*

Please see below for restrictions listed by State and **INELIGIBILITY** periods. Highlighted are those states with current restrictions.

Alaska – before May 8, 2023

Alabama – on or after November 1, 2023 and before April 2, 2024.

Arkansas – on or after November 6, 2023

California – on or after August 22, 2022

Colorado - on or after April 11, 2022 and before September 6, 2023; on or after December 5, 2023

Connecticut – on or after April 12, 2023 (extension of NY control area)

Delaware - on or after February 24, 2022 and before September 28, 2022

Florida – on or after October 21, 2022 and before July 18, 2023; on or after April 22, 2024

Georgia – on or after November 27, 2023 and before April 2, 2024.

Idaho – on or after April 29, 2022 and before July 18, 2023; on or after December 22, 2023

Illinois - before July 18, 2023

Indiana – on or after February 8, 2022 and before April 27, 2023; on or after February 5, 2024

Iowa – on or after March 9, 2022 and before September 28, 2022; before July 18, 2023; on or after October 30, 2023 and before April 2, 2024.

Kansas - on or after March 10, 2022 and before May 8, 2023; on or after November 20, 2023

Kentucky – on or after February 12, 2022 and before July 25, 2022; on or after September 15, 2022 and before August 10, 2023

Maine – on or after April 29, 2022 and before May 8, 2023

Maryland - on or after February 24, 2022 and before September 28, 2022; on or after December 16, 2022 and before September 6, 2023; on or after November 24, 2023 and before April 2, 2024.

Massachusetts – on or after March 11, 2024

Michigan – on or after May 3, 2022 and before July 31, 2023; on or after December 18, 2023

Minnesota - on or after March 31, 2022 and before July 24, 2023; on or after October 11, 2023

Mississippi - before July 18, 2023

Missouri - on or after March 6, 2022 and before September 28, 2022; on or after December 16, 2022 and before May 8, 2023; on or after November 9, 2023

Montana – on or after April 11, 2022 and before April 27, 2023; on or after October 13, 2023 and before April 2, 2024.

Nebraska - on or after March 29, 2022 and before July 31, 2023

Nevada – on or after October 21, 2022 and before April 2, 2024; on or after March 25, 2024.

New Hampshire – on or after September 23, 2022 and before July 18, 2023; on or after March 11, 2024

New Jersey – on or after September 21, 2023 and before November 22, 2023

North Carolina – on or after February 29, 2024

New York - on or after March 31, 2022 and before November 22, 2023; on or after December 21, 2023

New Mexico – on or after April 9, 2024

North Carolina – on or after March 29, 2022 and before September 28, 2022

North Dakota – on or after March 29, 2022 and before July 31, 2023; on or after November 20, 2023

Ohio – on or after September 3, 2022 and before April 27, 2023; on or after November 27, 2023

Oklahoma – on or after April 30, 2022 and before July 25, 2022

Oregon – on or after May 23, 2022 and before July 31, 2023; on or after October 27, 2023

Pennsylvania - on or after April 18, 2022 and before September 6, 2023; on or after January 2, 2023 and before April 2, 2024.

South Dakota – on or after March 6, 2022 and before September 6, 2023; on or after October 10, 2023

Tennessee – on or after February 12, 2022 and before July 25, 2022; on or after September 15, 2022 and before July 31, 2023

Texas – on or after April 2, 2022 and before July 25, 2022; on or after January 26, 2023 and before April 27, 2023; on or after April 9, 2024

Utah – on or after April 29, 2022 and before July 24, 2023; on or after October 13, 2023 and before April 2, 2024.

Virginia – on or after January 26, 2023 and before July 24, 2023

Washington – on or after May 9, 2022 and before July 18, 2023; on or after November 1, 2023

Wisconsin - on or after March 29, 2022 and before July 24, 2023; on or after November 30, 2023
