Certification Statements:

I, the undersigned USDA Accredited Veterinarian, certify to the following statements:

1. The farm of origin should be under the direct supervision of the USDA accredited veterinarian, provided that the farm or facility intended for export has been visited during the thirty (30) days prior to shipment by the USDA accredited veterinarian.

2. The day-old poultry for export originate from parent flocks which have been tested negative against the highly pathogenic avian influenza using serology at least twice during the last six (6) months prior to shipment, with one of the tests performed within thirty (30) days prior to shipment.

3. The flocks of origin of the hatching eggs for export should be located in a country, zone (10 km), or compartment that is free from highly pathogenic avian influenza virus per the World Organization of Animal Health (WOAH).
