## Products for Human Consumption Containing 2% or Less Meat Exported to Taiwan

The following information is based on information provided to the USDA by the quarantine authority of Taiwan, and is subject to change without notice.

#### I. MATERIALS COVERED

These are the requirements for the import of products containing poultry or pork meat or derivatives (2% or less) to Taiwan categorized as one of the following C.C.C. Codes:

- (1) 1902.20.10.10-9 "Other stuffed rice pasta, whether or not cooked or otherwise prepared, containing meat."
- (2) 1902.20.90.10-2 "Other stuffed pasta, whether or not cooked or otherwise prepared, containing meat."
- (3) 1904.10.20.91-9 "Other prepared foods obtained by the swelling or roasting of cereals or cereal products, containing not less than 30% of rice, containing meat."
- (4) 1904.10.90.10-2 "Other prepared foods obtained by swelling or roasting of cereals or cereal products, containing meat."
- (5) 1904.90.10.10-2 "Cereals (other than corn (maize)) in grain form or in the form of flakes or other worked grains (except flour, groats, and meal), pre-cooked or otherwise prepared, not elsewhere specified or included, containing not less than 30% of rice, containing meat."
- (6) 1904.90.90.10-5 "Cereals (other than corn (maize)) in grain form or in the form of flakes or other worked grains (except flour, groats and meal), pre-cooked or otherwise prepared, not elsewhere specified or included, containing meat."
- (7) 1905.40.00.10-4 "Rusks, toasted bread and similar toasted products, containing meat"
- (8) 2104.10.11.00-6 "Meat soups and broths and preparations therefor, liquid."

#### II. MATERIALS NOT COVERED

- a) Currently products containing ruminant origin items (beef, mutton, etc.) are believed to be prohibited.
- b) Canned (hermetically sealed) products are exempt from these requirements.
- c) Materials containing no animal origin ingredients except for those of dairy, egg, rendered animal fat/oil, extracts, hydrolysates, concentrates, flavors, shelf-stable dry meat powder, or fish origin are not covered by these requirements.
- d) Materials containing greater than 2% meat. The Food Safety and Inspection Service (FSIS) should be contacted for information on the export of products containing greater than 2% meat (i.e., Import/Export Coordination and Policy Development Staff at 202-720-0082; or the Policy Development Division at 402-344-5000). APHIS-VS does not issue export certificates for products for human consumption if those products contain greater than 2% meat.

### III. REQUIREMENTS FOR ELIGIBILITY

- a. The manufacturer must be approved by a competent authority in the US to produce the product. The competent authority must be a governmental regulatory authority such as the Food and Drug Administration (FDA), a State Department of Agriculture, or a local authority with jurisdiction over foods for human consumption. Documentation from economic entities such as the Chamber of Commerce is not acceptable.
- b. Animal origin ingredients, other than those of dairy, egg, rendered animal fat/oil, extracts, hydrolysates, concentrates, flavors, shelf-stable dry meat powder, and fish origin, and vitamins, must bear the FSIS mark of inspection, or, if imported, be imported with certification from the government of origin verifying that the material is derived from animals that passed ante and post-mortem inspection.
- c. Products must be packaged in new containers.
- d. The manufacturer (which may not be the same individual as the exporter) must maintain records for each lot of product to be exported for at least two years after production. These records must contain the following information:
  - o Species of origin of meat
  - o FSIS approved production facility of meat (if domestic)
  - o If meat is imported, copies of government issued export certificates
  - o Quantity and date of receipt of meat ingredients
  - o Date of production of the final product.

# IV. REQUIREMENTS TO OBTAIN VS FORM 16-4 (ANIMAL PRODUCTS EXPORT CERTIFICATE) FROM APHIS FOR THE EXPORT OF THESE PRODUCTS

In addition to meeting all other APHIS-VS requirements (for obtaining the VS Form 16-4), the exporter must meet the following requirements. (Exporters should contact their Veterinary Services Service Center for more information.)

- a. Documentation from the Food and Drug Administration (FDA) or other competent federal, state, or local authority must be provided verifying that the **manufacturing** facility is "approved" to produce the product. This documentation may take the form of a certificate of free sale <u>from the FDA</u>, or other official documentation from another competent authority. (See item IIIa for more information on acceptable authorities).
- b. A <u>notarized</u> affidavit, on company letterhead, must be provided by the product manufacturer to the VS Service Center issuing the export certificate. <u>This</u> <u>document must be produced and endorsed by the manufacturing company, which is not necessarily the same entity as the exporter.</u> This affidavit must contain the following statements:

The production facility maintains the following records for all products exported to Taiwan for at least 2 years:

- a. Species or origin of meat
- b. FSIS approved production facility of meat
- c. Quantity and date of receipt of meat ingredients
- d. Date of production of final product

"The product has been heat-treated so that the core of the product (the minimum internal temperature) has reached a temperature of at least 65 °C for a minimum of 42 seconds, or at least 70°C for a minimum of 3.6 seconds, or at least 74°C for a minimum of 0.51 seconds.

Certified materials have undergone all precautions to avoid contamination with pathogens causing animal diseases during and after treatment."]

c. At the discretion of the APHIS Service Center, APHIS may require inspection, at the manufacturing facility's expense, to verify all export requirements.

#### V. CERTIFICATE REQUIRED:

Products exported must be accompanied by a VS Form 16-4 (must be issued prior to the date of shipping).

The VS Form 16-4 must contain the following statements in the additional declaration area (no further information may be included):

This is to certify that rinderpest, foot-and-mouth disease, classical swine fever, swine vesicular disease, African swine fever, and contagious bovine pleuropneumonia do not exist in the United States of America.

This office has on file a notarized affidavit from [insert name of company] verifying the accuracy of the statements below.

Certified materials have undergone all precautions to avoid contamination with pathogens causing animal diseases during and after treatment."

The "PRODUCT" box of the VS Form 16-4 must also include <u>name</u>, <u>quantity</u>, <u>and</u> <u>weight</u> of the certified material, as well as a product description.
