V. Animal Health Attestations

I, the undersigned, certify that the horse described above meets the following requirements:

- a. The horse resided in the country specified above for _____ (number) day(s).
- b. The horse described was inspected on the premises of temporary residency listed above on (mm/dd/yyyy) and found to be free of contagious diseases and, insofar as can be determined, not exposed to communicable or contagious diseases immediately preceding exportation, or during the indicated period of residency.
- c. The horse has not been vaccinated with a live, attenuated or inactivated vaccine during the period of residency if within 14 days preceding exportation to the United States.
- d. Insofar as I can determine, African horse sickness (AHS), dourine, glanders, surra, epizootic lymphangitis, ulcerative lymphangitis, equine piroplasmosis, equine infectious anemia, contagious equine metritis (CEM), vesicular stomatitis, and/or Venezuelan equine encephalomyelitis has not occurred on the premises of temporary residence during the period of residency, nor have these diseases occurred on any adjoining premises during the same period of time.
- e. The horse was examined and found to be free of ectoparasites.
- f. APHIS recognizes the country of residency to be free of AHS.²

VI. CEM Attestations

a. APHIS recognizes the country of residency as free of CEM and, during the indicated period of residency listed, the horse did not have any contact, breeding or otherwise, with horses from a premises affected with CEM or horses found to be affected with CEM.^{1,2}

- b. APHIS recognizes the country of residency to be affected with CEM and, insofar as I can determine, the horse: ^{1,2}
 - has been held separate and apart from all other horses except for the time it was actually participating in an event or was being exercised by its trainer;
 - has not been on any premises where horses were held or used for breeding purposes;
 - has not been bred, either live or artificial, nor had other sexual contact or genital examination while residing in the above country; and
 - has been transported only in cleaned and disinfected vehicles and was not accompanied by any other horse of a different health status.

VII. Foot and Mouth Disease (FMD) Attestations

a. APHIS recognizes the country of residency free of FMD.^{1,2}

b. APHIS recognizes the country of residency to be affected with FMD and the FMD mitigations outlined in *Requirements for Horses that Reside in Multiple Countries of Differing Health Statuses Prior to Exporting to the United States* **have not** been performed.^{1,2}

APHIS recognizes the country of residency to be affected with FMD and the FMD mitigations outlined in *Requirements for Horses that Reside in Multiple Countries of Differing Health Statuses Prior to Exporting to the United States* **have** been performed as certified in the attached certificate or addendum.^{1,2}

VIII. Screwworm Attestations

a. APHIS recognizes the country of residency as free of screwworm and no screwworm mitigations were performed.^{1, 2}

b. APHIS recognizes the country of residency to be affected with screwworm and the screwworm mitigations outlined in *Requirements for Horses that Reside in Multiple Countries of Differing Health Statuses Prior to Exporting to the United States* **have not** been performed.^{1,2}

OR

c. APHIS recognizes the country of residency as free of screwworm AND the horse has temporarily resided in one or more countries that APHIS considers screwworm affected AND the mitigations outlined *Requirements for Horses that Reside in Multiple of Differing Health Statuses Prior to Exporting to the United States* have been performed as certified on the attached certificate or addendum.^{1,2}

IX. Venezuelan Equine Encephalitis (VEE) Attestations

a. APHIS recognizes the country of residency as free of VEE and no VEE mitigations were performed.^{1, 2}

OR

b. APHIS recognizes the country of residency to be affected with VEE and the VEE mitigations outlined in *Requirements for Horses that Reside in Multiple Countries of Differing Health Statuses Prior to Exporting to the United States* **have not** been performed.^{1,2}

OR

c. APHIS recognizes the country of residency as free of VEE AND the horse has temporarily resided in one or more countries that APHIS considers VEE affected AND the mitigations outlined *Requirements for Horses that Reside in Multiple of Differing Health Statuses Prior to Exporting to the United States* **have** been performed as certified on the attached certificate or addendum.^{1,2}
