CERTIFICATION STATEMENTS:

- 1. The United States is free of foot-and-mouth disease, goat and sheep pox, peste des petits ruminants, and Rift Valley fever.
- 2. Scrapie is a notifiable disease in the United States and the feeding to sheep and goats of meat-and-bone meal or greaves of ruminant origin is been banned and effectively enforced in the United States.
- 3. Each animal was identified by a permanent identification system recognized by the USDA.
- 4. The animals were isolated for at least 21 days immediately prior to export in a facility approved by, and under the oversight of, the USDA-Accredited Veterinarian.
- 5. The animals were inspected on the isolation premise within 21 days prior to export by the USDA-Accredited Veterinarian, and found to be free from clinical evidence of communicable disease including caprine arthritis/encephalitis or maedi-visna, paratuberculosis, bluetongue, and brucellosis.
- 6. The flock(s) of origin:
 - a. Has had no clinical cases of scrapie disease in the last seven (7) years prior to export.
 - b. Has had no clinical cases of caprine arthritis/encephalitis and/or maedi-visna in the last three (3) years prior to export.
 - c. Has had no clinical cases of brucellosis in the last twelve (12) months prior to export.
